Greetings! As we look back on a record setting year, we are extremely humbled by the ongoing support of this community.

Being chosen as the next President & CEO is a huge honor and I am excited about moving the organization forward to becoming a countywide organization.

It is because of your continued belief in our young people and our mission we can expand our reach & impact. As a result of our growth in 2022, we officially changed our name to the Boys & Girls Clubs of Carroll County, Inc. We now have five club houses associated with our organization, located in Westminster, Hampstead, Taneytown, Sykesville, and Mt. Airy.

Our approach is simple... we mentor kids and grow leaders. Staying true to our mission to serve youth and families, especially those that need us most, has allowed us to rebound from the pandemic and continue our growth. We had a record-breaking summer camp, serving 175 kids each week as well as a successful membership drive which engaged even more youth in our afterschool program. We grew our membership 61% this year.

The future of our Club includes ensuring that our kids have healthy strategies in place to help them realize their full potential. Our vision was realized this year when we added a full-time social worker to our staff. We are thrilled that we can continue to create an environment that is physically and emotionally safe for our youth.

Youth, families, staff, Board Members, Trustees, volunteers, partners, and donors – each of you plays an important role in our club community. We are grateful to everyone who commits themselves to the success of the Boys & Girls Clubs of Carroll County and to the young people we serve each day.

This year we celebrated **Jamison Welsh** receiving the title of Maryland Youth of the Year. Jamison has spent this past year as spokesperson for youth throughout Maryland and even got to meet with Governor Hogan several times. Most recently, Jamison met with elected officials in Annapolis to advocate for Boys & Girls Clubs programs across the state. Jamison was thrilled to represent Boys & Girls Clubs of Maryland at the Northeast Regional Youth of the Year Competition in New York City in June 2022. Other exciting honors for her included: throwing in the first pitch at the Orioles Game, Judging the Crab Soup Cookoff at Fleet Week and being honored at the Ravens vs Steelers game on New Years Day.

Jamison is a special young person who freely gives her time to help others. She mentors youth at the Club helping them develop healthy coping skills and build positive relationships. She is an advocate for finding healthy coping strategies that support youth when they are dealing with peer pressure, family challenges and the difficulties associated with adolescence. Jamison often draws on her firsthand experiences to inspire her peers to develop a "can do" attitude. She urges youth to build resilience by using the safe space at Boys & Girls Club to participate in activities that might otherwise be outside their comfort zone. Jamison will receive **The Albers Family Youth of the Year Scholarship** for \$500 and a scholarship from Boys & Girls Clubs of America for \$2,500 for being named as Maryland Youth of the Year



Kohl's Cares for Kids – **KOHL'S WIDS**

The Kohl's Community with Heart Program has been instrumental in helping us to reach more youth in our community with targeted social emotional wellness programs. We have received contributions from Kohl's for the past three years – this year they surprised us with a \$30,000 gift. The Kohl's funds helped us put wellness programs in place that reinforced positive mental health and gave our kids the chance to engage with mentors and develop positive peer support systems. We addressed post-COVID burnout by adding more interactive programs that build confidence, trust. and resilience. We hired more support staff, provided daily wellness activities, and expanded our programming to an additional middle school site at Mt. Airy Middle School. We love working with the Kohl's associates – their engagement at the Club has vielded positive results with our members, providing them with mentors and a connection to the community. We are incredibly thankful for Kohl's support of our kids and our community.






Leadership & Workforce Development

We piloted a Workforce Development program this year, funded by **The Kahlert Foundation**, which was designed to educate, build interest, and increase hands-on experiences for middle and high school youth. The program allowed our young leaders to EXPLORE their interests, EXPOSE themselves to various careers through field trips and guest speakers and ENRICH their knowledge of workforce development opportunities.





Knorr Brake Company mentored our young leaders on resume writing, filling out a job application, interviewing skills and dressing for success. Then with all their newly acquired skills, the teens attended a three-week workforce development summer college program at **Carroll Community College**. The program combined career education with hands-on opportunities to try different certificate programs at the college. During the 3 weeks, youth tried out different programs, including welding, dental assistant, pharm tech, nursing, phlebotomy, auto mechanic, electrical, entrepreneurship and drone technology.







Positive Mental Health



We added Mollie Yingling, as Social Emotional Wellness Director to our staff this year. She is a licensed social worker and works with our youth and families to build positive coping skills. Social emotional wellness is addressed daily at the Club through lessons on mindfulness, healthy coping skills and positive self-esteem. Our kids look forward to each of the daily activities: Mindful Mondays, Time to Read Tuesdays, Wind Down Wednesdays, Think it Out Thursdays and of course, FUN FRIDAYS!

Podcast

Our Teens have a Podcast! Teen Talk Uncensored provides teens a platform to share their opinions on issues that affect them and the world around them. They have discussed: Vaping, Substance Use, Positive Mental Health, and Leadership. Reed Wraase from On the Edge Consulting hosts our Wednesday

podcast, complete with professional equipment. The teens love the chance to share their opinions. We will release a BGC Podcast series at the end of the year.



Knitting Club

Our weekly knitting club is designed to relieve stress and teach positive coping strategies. We started the club this summer and soon outgrew the mentoring room space. In addition to learning new skills, we also engage in conversations that address healthy ways to cope.

We developed *Our Knitting Rules of Life*, which guide our sessions... and our life. The rules include:

- Beginnings & Endings are hard
- Oopsies Happen
- Sometimes you must Improvise, and
- It's okay to let someone take a row for you!

This is a club

favorite among our middle schoolers. We always love to have knitting volunteers join us to share their life lessons. Currently we are knitting cat toys to donate to the Humane Society.


